**“Without CAIR Coalition, people like myself would not be sitting here today.**

*Molley (left) was a child soldier in his country and came to the United States in the early 1990s to seek refuge and safety. He has had a green card since 1997 and lives in Maryland with his children and partner.*

After struggling with his mental health, Molley was ripped away from his family by Immigration and Customs Enforcement and sent to a detention center in Georgia, more than 800 miles away from his home.

**“My kids are my life,” said Molley. “Because I know what it was like growing up without parents. And I made a deal with God and myself that I would never, ever, not be in their lives.”**

But in September of 2022, while he was in detention, Molley was connected with an attorney from CAIR Coalition.

“The hardest thing [about being in detention] was knowing that a person like myself, who has gone through so much—from the civil war back home to coming to a new country with so many obstacles—could then be locked away. With a snap of a finger, my whole life just came crashing down.”

CAIR Coalition argued that the Immigration judge should terminate Molley’s case because the crime was not a “ground for removability,” a crime that allows green card holders to be deported.

The judge agreed. But then, the Department of Homeland Security appealed.

CAIR Coalition went through the entire appeals process with Molley while he was in detention for nine months. Together, we defended that termination order before the Board of Immigration Appeals (BIA). Finally, in March, we got the decision that the BIA agreed with the termination.

After nine months in immigration detention, Molley was finally released! He is now safe at home with his family and community.

## Lawsuits Litigated

CAIR Coalition's Immigration Impact Lab has litigated over 40 lawsuits to challenge barriers to asylum, minimize the consequences of criminal convictions, and protect due process rights for those who are detained.

This includes habeas petitions, a novel area of immigration law where we continue to make significant strides. Immigrants who are subjected to prolonged or unlawful detention have a right to seek release through habeas petitions.
